

Notice is hereby served that the Warren County Board of Commissioners will hold a Public Hearing on **Wednesday, August 19, 2009 at 5:30 pm**. The hearing will be held in the Warren County Memorial Library Community Meeting Room, 109 S. Front Street, Warrenton, NC. The purpose of this hearing is to receive citizens' input on proposed FY 2010 Warren County's application for FY 2009-10 Rural Operating Assistance Program funding.

The Rural Operating Assistance Program (ROAP) consolidates:

Program	Allocation	FY 2010 Supplement
Elderly and Disabled Transportation Assistance Program (EDTAP)	\$41,571	\$23,797
Work First Transitional/Employment Transportation Assistance Program	\$5,232	\$6,493
Rural General Public (RGP) Program	\$34,630	\$30,454

into a single funding package. Warren County's proposed allocation for FY 2009-10 is \$142,177. Said funding will be utilized for the expansion of transportation assistance to eligible residents, i.e., Work First recipients, the elderly and disabled as well as the local community transportation providers administered by the Department of Social Services, the Warren County Senior Citizens Center and Area Mental Health.

The application is available for inspection at the Warren County Manager's Office, PO Box 619, 105 S. Front Street, Warrenton, NC 27589.

A special meeting to adopt FY 2009-10 ROAP application will follow public hearing at 5:45 pm in the same location.


Public Hearing Procedures


