Pursuant to NC General Statute 159-12, notice is hereby given that the Warren County Budget Estimate for FY 2014-15 has been submitted by the County Manager to the Warren County Board of Commissioners. A Public Hearing on the proposed budget for FY 2014-15 will be held in the Warren County Armory Civic Center, 501 US Hwy 158 Business East, Warrenton, NC 27589 on Wednesday, June 18, 2014 at 6:00 p.m. The public is reminded that the budget is proposed by the County Manager, and as such, may change following final actions of the Board of County Commissioners which may also include changes in the proposed tax rate.


At the time of the Public Hearing, all interested citizens shall have the right and reasonable opportunity to provide either written and/or oral comments concerning the proposed budget and to ask questions regarding the entire budget, or any component thereof. The proposed budget totals \$30,478,263 and the proposed tax rate is \$.66/\$100 property valuation.
